Illinois Law requires suppliers provide access to a one-year price history for residential variable rate products. The chart below shows the highest and lowest variable generation rates charged by Public Power over the past twelve months. Historical pricing is not indicative of present or future pricing.

As of January 1, 2025, the electric supply price to compare is currently 6.552 cents per kWh in ComEd and 8.277 cents per kWh for < 800 kWh and 7.693 for 800+ kWh in Ameren. The utility electric supply price will expire on May 31, 2025. The electric utility electric supply price to compare does not include the purchased electricity adjustment factor. The purchased electricity adjustment factor may range between +0.5 cents and -0.5 cents per kilowatt hour.
